The transcription is labeled as a "list of lands now held by the State" which was "forfeited for taxes in Tishomingo County, State of Mississippi, furnished to the Chancery Clerk of said County by the Auditor, under the provisions of an act entitled *An Act to Facilitate the Sale of Lands Held by the State for Taxes, Correct Erroneous Sales and Assessments and Indefinite Descriptions, and for Other Purposes*, approved February 22, 1890."
