COURT RULES AGAINST HOSPITAL BOND ISSUE

Decision Filed in Circuit Clerk's Office This Week

A decision was rendered by the Hon. Raymond T. Jarvis, circuit judge, on October 15, 1949, and was filed in the circuit clerk's office October 25, 1949, on the objections to the proposed community hospital bond issue. He based his opinion on the following points: The judge stated that in his opinion the people voted on a bond issue to construct a hospital and related facilities. The words "related facilities" were too ambiguous to inform the voters as to just what would be constructed. He stated further in his opinion that the interest rate was to be an average of 2.90 per cent for the life of the bonds. The interest rates were split, and for a certain period the interest rates would be less than 2.90 per cent, but the average rate never exceeds 2.90 per cent. The judge held in his opinion that it was not legal to split the interest rates, but should have been 2.90 per cent starlight through.

The lawsuit grew out of exceptions and objections of citizens, tax payers, and the Board of Supervisors over ruled the objections, and the case was appealed to the Circuit Court. In the Circuit Judge's opinion, he ruled that the Board of Supervisors was in error and the cause was reversed which means the court's judgment is against the issuing and selling of these bonds for the construction of the community hospital.




