Put Darden & Wes Whitney were at the burying.

Jan. 4: George went to school. Mr. Darden went to Fayette; went by Mr. Hicks; they are so distressed, about Beverly. He was taken first with earache, then pneumonia; after he was confined to his room, one of the professors took him to his house, was very kind to him, the boys were too. The Dr.'s blistered him severely. Would not let him have water. Lizzie said all his wish was to see her. They got there at 1 oc., Thursday morn. he died at 7 oc., that night. They saw Jesse, he was well & doing well. Eddie came home with his Ma & Pa. They will not send him back to Oxford. It was a sad scene to have a child die so far away from home. I know how to sympathize with them from my own afflications. Laura went to Jack's this evening, expected to find Henry & his wife there, but she did not come down with him. Henry and Jack went to Natchez this eve. They had a large wedding at brother Buck's. Cate will go Mon. to help Mrs. Stewart's mother. Stayed a week; spent a day & night with Ellen Goode in Thibadeaux. Ellen has a sweet babe. Jennie Percy has a daughter born in Nov.

Jan. 11: Johnnie Tate is five years old today. Henry Darden & his Pa went to Natchez today. Tom Darden & Pros Whitney went by going home from Natchez.

Jan. 15: Laura received a letter from Jennie McGehee; she seems anxious for Laura to visit her.

Jan. 16: Henry & Kate Darden went to his Pa's yesterday. Mr. Bridewell came at 5 oc., this eve. Dr. Tully Stuart Gibson was shot & dragged about in his yard before he died in Sunflower County by a company of Federal soldiers.

Jan. 20: Received a dispatch from Mr. West saying Irene had another daughter. She was doing well; wanted me to come if it was convenient. Mr. Dixon moved to Joe Davenport's today.

Feb. 6: I left Irene crying at 8 oc, poor thing; how lonesome she will be. I stayed at the Henrietta House till 3 oc. Col.

Roberts went on the 'Wild Wagoner" with me. The Wagoner got to Natchez at 8 oc. The Capt. came off the boat to the carriage with me. Capt. Walton was on the boat. I got home half past 4 oc. Miss Kate Wade was married to Mr. Newell of Tensas Parish last Wed. Feb. 2. Miss Rosa Scott, niece of Jeff Briscoe, died at Nazerath in Oct.

Feb. 9: We all went to the Presbyterian Church to see Lena Stuart and Hugh Montgomery married. There was good many there. Mr. Hall performed the ceremony. Laura & Mr. Dough Montgomery stood together. Hung Montgomery & Miss Kate Montgomery together. The bridal company went to Capt. Sam's to dinner.

Feb. 10: Laura got home from Capt. Sam Montgomery's after 8 oc. Ella Torrey, Lou Darden, Kate & Henry, Letha Scott, Sue & Mr. Armistead & the young men from Fayette were there. Danced till day. Lena will go to Rodney in the morning.

Feb. 11: Laura went to the Gipsey Camp, found Kate Darden & Dewitt Dixon there.

Feb. 12: I washed up the plates, cups & saucers to have ready for Laura's wedding.

Feb. 14: Mr. Darden went to Dr. Tate's for Olivia & Dr. to come up to see Laura married.

Feb. 15: Mr. Darden went to Fayette, met Julia & Mr. Wade there. Julia thought today was the wedding. Martha & the children came at 1 oc. Mr. Bridewell came to Dr. Wade's to dinner. Dr. Wade went with him to get his license. His wagon came on with Dr. Wade here to take Laura's trunks to Port Gibson. Martha, Olivia Laura & I sit the table tonight.

Feb. 16: Mr. Bridewell brought Mr. Hall out in the carriage; they got here a 11 oc., the ceremony was performed half after 11 oc.; had breakfast at 12. Dr. Tate came after the ceremony was over. Feb. 28: Mr. Darden went to Fayette, got a letter from Laura. They stayed all night at Dr. Wade's the eve they left here. Got to Port Gibson Thurs. at 1 oc., were cordially received by Mrs.

Bridewell. His sister Mrs. Mallory, had a nice dinner. Mr. & Mrs. Price, Willie Darden, Dick Scott & Mrs. Vertner had called on them. Mrs. Dunbar, Vertner, Seviers, Archer's, Rosa Calhoun & some others sent word they could call as soon as the weather turned warmer. Laura did not think they would go to Zazoo with Mr. B.'s sister as it was necessary for him to be at home. Lizzie Briscoe was married to Mr. P. Tunstall of New Orleans last Wed. 23rd Feb. He is in commission business in N. O. Mr. Darden saw Mrs. General Clark pass through Fayette going to Mr. Hicks. Ella Torrey was with her.

Mar. 3: Mr. Darden went to Jack's; Henry & Kate are going to live there. Jack has rented his Hines land to Dennis for 2 bales of cotton. Jack has been to see Mary Scott. He took dinner on 17th at Dr. Tate's.

Mar. 4: Old Mr. Dick Compton has moved to Washington to send his boys to school. His son Stephen is managing his place.

Mar. 8: Henry & Kate went back to Jack's this evening; had been to brother Buck's.

Mar. 9: Tip Montgomery moves his family to Beuff River today.

Mar. 10: Dr. Wade wrote he wanted Mr. Darden to make him a deed to his land. Mr. Darden bid it in when it was sold in.

Mar. 12: Mr. Darden got a letter from Jesse. There good deal pneumonia at Oxford. One of the students died 5th March.

Mar. 28: Court in session in Fayette.

Mar. 30: Mr. Montgomery got a dispatch from Tip, saying his little girl 16 years old, died with diptheria, just after they got to Beuff River where they had moved.

- Apr. 15: George says Henry & Kate Darden were at the Academy today.
- Apr. 16: George spent the day with Minor Dixon's son, fishing & etc. They live three miles from Fayette in a house with one room, dirt chimney. Mr. Darden went to Fayette, got a letter from Jesse & old Mr. Huey, who used to live in this County.

- June 17: Mr. Davenport had been to see Jack. He thinks he is very bad off.
- June 18: George started to see Pic Dixon; came back when the rain began. Mr. Darden received a letter from Mary Scott. She is having chills & fever. We had a letter from Jesse; he said Brad Coffey had chills & fever. There was a good rain from Pros Whitney's to Fayette. Mr. Darden went to see Jack. He is better this eve. Dr. Guice was uneasy about Jack.
- June 20: Mr. Darden went to the Salem graveyard to assist Dr. Hill put up the monument to his Pa & Ma's graves. Cicero Stampley eat dinner here. He is anxious to sell the Henry Stampley place to Mr. Darden. They sent us a ticket to old Hugh Montgomery's funeral.
- June 21: Mr. Darden went to the graveyard (Salem). Dr. Hill put up the iron railing & monument. I went to Mr. Hugh Montgomery's burying. Rev. Will Johnson preached his funeral. He was buried

at home where his wife & children are buried. He had great, great, grandchildren at his burying. Mrs. Ratliff, his daughter, was with him during his last sickness. He would have been 84 years old in November.

July 7: Jesse eat dinner at Uncle Jack's. Henry came up with him. Stayed till sundown. He wants Jesse to go to Bolivar County with him.

Miss Eudora Gordon was first maid of honor. Miss Bell Sildon, second maid of honor. Mary Bondurant & her little daughter, Deloise, Eva & Annie

Seymour & Mrs. Stockton eat dinner with us. Josse came to the Fair with some of the college boys in a wagon. They had to go back tonight. Mr. Bridewell went back to Dr. Wade's; Laura came home with us.

Oct. 22: Laura, Irene & her children spent the day at Uncle Prosper's. Cousin Mary Bondurant will leave Monday for home in La. near St. Joseph. Julia & Mr. Wade came at sundown.

Oct. 25: Rev. Dr. Chase died near Natchez on 3rd October in his 82 year; Presbyterian minister. Chambliss Calhoun's wife died with consumption last week.

Oct. 27: Mr. Darden went to Natchez with Irene & her children. How sad I felt when they left; we may never all meet again.

Oct. 28: Mr. Darden got home at 4 oc., left Irene on the wharf boat. The Wagoner had not come. They stayed on the wharf boat last night. Did not get a good nights rest. The Steamers Rob. E. Lee & Natchez were racing; there was a crowd at the wharf when they got there last night firing cannon & shooting rockets. They had all the stores closed in Natchez yesterday doing honor to Gen. Rob. E. Lee's death. They marched through the different streets; very large processions to the Institute hall, where Judge Shields addressed the audience.

Oct. 30: Mr. Darden & George went to the Methodist Church. Mr. Glenn will preach once more & leave for Georgia.

Oct. 31: Mr. Darden went to see Ira Robertson; he married a widow with one child. They are on a visit to his mother. Ira Owes Mr. Darden \$160. He says he will pay it when he comes to Conference. Mrs. Dixon has gone back to Joe Davenport's to cook. Laura West is 2 years old today. Laura received a letter from Reeves Wade wanting to borrow \$3,500. Laura's money is loaned in Natchez, therefore she could not let him have it. He was willing to give a Deed of Trust on the land he bought from Rob. McDonald. Jimmie Sillers died in Bolivar in October; was brought to Port Gibson to be buried.

Nov. 10: There was a bill of \$27 came against Jesse today from Oxford. His Pa is very much displeased about the bill. He wrote to Jesse giving him a lecture.

Nov. 12: News came to Fayette that Charley Pipes living near Natchez had shot and killed Cambell Marsh. Mr. Marsh is separated from his wife; he went to Mrs. Pipes (her mother), was told not to go in Mrs. Marsh's room. He went & was shot.

Nov. 15: Mr. Darden saw Frank Montgomery this eve he says his crop is not good.

Nov. 16: Mr. Darden saw Cicero, he is very much discouraged; his crop is not good. Dr. Weatherly wants him to go on his place in the swamp next year.

- Nov. 20: George is 12 years old today. Mrs. Stephen Guice was at Church today; she is soliciting aid for the Orphan Asylum in Natchez. She is a sister of Mr. Tom Reed's.
- Nov. 22: Circuit Court is in session, Judge Alderson on the bench. Dr. Hill's case was to be tried for living with a colored woman & then deserting her. What shame to have to try such cases in court.
- Nov. 24: Mr. Darden brought a letter from Irene, she says they have been in great distress since the 9th Nov. They received a dispatch that Capt. Ab. Cage died suddenly that morning, with rheumatism of the heart. His remains were brought to Bayou Sara on the Steamer Pargoud, carried on the cars to the family burying ground about 13 miles from Woodville, Wilkinson County. Capt. West, Willie & Tommie West met the corpse at Bayou Sara. Capt. Cage was buried by the Mason's. His son, nephew & number of acquaintances came with his remains from his home in Terrabone Parish, La.
- Nov. 25: Mrs. Billy Stampley was buried in Fayette this eve. She died at Wash Manifold's. She was the mother of Jeff Stampley. Old Capt. Bullen died suddenly this evening.
- Nov. 28: Mr. Darden went to Fayette, then to Dr. Wade's. Miss Agnes Wade has been cooking for Dr. Wade for a week. Dr. Wade was having the Rosswood place surveyed today. Sallie Wade is going to give her interest in the Rosswood land to Mattie & James Taylor for their interest in the land in South Carolina. Mr. Tim Wade will be on soon & Sallie will go back to Carolina & live with him & Miss Agnes Wade. Reeves Wade was at Dr. Wade's Sunday, he is trying to rend land near there.
- Dec. 2: Henry Darden started to Bolivar today, little Buckner with him. Lulie (Stuart) Gordon's babe is a boy from 28th Nov. Henry Darden went to Bolivar to get some one to go on the land his Uncle Buck gave them. Old Mr. Dunc. Buckel's died in a spree Saturday Dec. 3rd.
- Dec. 7: Mr. Darden went to Fayette, put letter in office to Mr. Tom Spires of Madison Parish about his landthere. Cicero called at the garden; told me his wife has another daughter that it was born Monday; that is 6 children they have.
- Dec. 17: Mr. Darden went to Fayette to act as Commissioner to divide Judge Whitney's land. Mrs. Whitney & Miss Kate got their part of the land & Mittie got a part for a debt that the estate of Judge Whitney owes them. The Commissioners did not transact any business; they dined at Jeff Whitney.
- Dec. 24: Capt. Adam's mother died last week. She was the mother of Angela Adams that Martha & Olivia went to school with in Natchez. He is teaching in Oakland. The Steamer Robert E. Lee collided with the Steamer Patomac. The Lee sank in a few minutes; the freight was saved, except for Vicksburg which was in the hold. It happened as the Lee was backing out from the Natchez Landing.

They have raised the Lee, she went back to N. O. for repairs. Rob McGinty told Mr. Darden he rode across a pond frozen so hard it did not break.

Dec. 25: Mr. John Dick's & Ann Elize McArn's marriage is announced. They were married Dec. 5.

Dec. 29: Tom Darden & Dis Briscoe passed going to Pine Ridge.

Dec. 30: Wesley Whitney came this morning to borrow \$600; he has bought Jim Wigginton's place (120 acres) just back of the fair grounds near Fayette. Was promised the loan of the money. Mr. Darden went to Fayette to see if he could collect the money Blount Stuart owes him (\$900). Blount said he could not pay it. So he did not let Mr. Whitney have any.

Dec. 31: Mr. Davenport came to get Mr. Darden to sign a petition to the board of supervisors to establish a free white school in this district.
